

# Recycling Items Not Accepted by Cascade

*Cascade considers some equipment as “non-conforming” because we cannot safely process it for reuse or recycling. This sheet provides some resources to help you find legitimate recycling outlets for this equipment.*

Cascade is capable of effectively and safely processing most information technology equipment and office electronics. We are also able to process certain electronic medical equipment and industrial equipment when they meet our specific acceptance guidelines and receive pre-approval from Cascade prior to pickup. There are some electronic items Cascade is not suited to process, and we call these items “non-conforming equipment.” If we discover non-conforming equipment at a customer site during pickup, we will leave the equipment and alert the customer that we cannot process it. If we discover non-conforming at our processing facilities, we will notify the customer of the non-conformance and ask if they want the equipment back for proper processing, or we can offer some other disposal options for an additional fee. The non-conforming equipment handling policy is defined in our standard terms and conditions (available at our web site: [www.cascade-assets.com/terms](http://www.cascade-assets.com/terms)) or in most customer agreements.

## Common equipment received by Cascade considered to be non-conforming

Here are some examples of various types of equipment Cascade is not suited to process:

- **Household appliances** (large refrigerators, ovens, dishwashers)
- **Equipment containing refrigerant gases** (air conditioners, dehumidifiers)
- **Any liquids or chemicals** (cleaners, reagents, solvents, paint, gases)
- **Fluorescent lamps and other light bulbs** (any lamps from lighting fixtures)
- **Medical equipment with a bloodborne pathogen risk** that has not been decontaminated
- **Radioactive materials** (some exit signs, smoke/carbon monoxide detectors, contaminated medical equipment)
- **Solid waste or other trash** (large amounts of rubber or glass, linens, anything with asbestos)

## Options for disposing of these items safely

If your organization has a Safety or Risk Management department, be sure to check with them first for appropriate disposal options for items Cascade considers non-conforming. You may already have a contract with a service provider set up to handle these items. Typically, companies have vendors who provide appliance recycling, lamp recycling, solid waste disposal, or medical waste processing. Your organization’s disposal liability is better protected when ensuring the appropriate contractor is given waste it is capable of handling.

There are a variety of places to find other options to dispose of typical hazardous wastes. First, contact your county’s Clean Sweep program. They help businesses and households dispose of a wide variety of hazardous materials. Also, each state often maintains a “Recycling Markets Directory” listing companies who specialize in recycling a wide range of equipment. Use “Google” to look up local and state recycling programs.
